Principal activities

The main object of the Canal Communities Regional Addiction Service CLG (CCRAS) is to work in an integrated and collaborative way with services users and their families, and with communities, community groups, local drug and alcohol services, statutory agencies and other relevant organisations, to respond effectively to the causes and consequences of problem drug use, alcohol use and addiction in the Canal Communities area of Dublin (Bluebell, Inchicore and Rialto). The company provides a variety of services and supports to individuals struggling with drug and alcohol use, to affected families and to the wider community.

Development and performance

The company initiated, expanded, continued to lead, or supported several important inter-agency activities locally during the year. New initiatives of this type included: the production of an information booklet on benzodiazepines; the engagement of a researcher to assist the Canal Communities Local Drug and Alcohol Task Force to draw up a long-term strategy to reduce violence locally; and the organisation of a series of anti-racism training workshops for community members and local staff. Longer-standing work also continued, for example: the organisation of two well-attended 'Drug and Alcohol Awareness Weeks'; support for estate regeneration; the running of existing mutual support and education groups, including Alcohol Education and Support, Women's, 'SMART Recovery' and Benzodiazepine Support groups; the production of the service users' magazine, Vocaleyez; supporting the Community Representatives on the Canal Communities Local Drug and Alcohol Task Force; running a 'Recovery Choir'; one-to-one supports and social activities for people who have become drug-free.

In October 2024, the company took over all the activities of the Canal Communities Local Drug and Alcohol Task Force CLG, the assets of the latter company having been transferred to CCRAS the previous month. These were key steps in the effective merger of the two companies: earlier in the year, the Directors of the Canal Communities Local Drug and Alcohol Task Force CLG had joined the CCRAS Board. As the final step in this process, the Canal Communities Local Drug and Alcohol Task Force CLG resolved in December 2024 to apply to the Registrar of Companies for that company to be struck off the register on the grounds that it had ceased to carry on business.

Financial results, assets and liabilities and financial position

The retained surplus for the financial year amounted to €158,949 (2023: €90,659) and this was transferred to restricted reserves at the year end. At the end of the year the company had assets of €326,472 (2023: €168,645) and liabilities of €13,534 (2023: €14,656). The net funds of the company are €312,938, (2023: €153,989).

Principal risks and uncertainties

The Directors have identified that the key risks and uncertainties the company faces relate to the risk of reduced state funding in the future and of the potential increase in compliance requirements in accordance with company, health and safety, taxation and other legislation;

The company mitigates these risks as follows:

i) The company continually monitors the level of activity, prepares and monitors its budgets targets and projections. ii) The company closely monitors emerging changes to regulations and legislation on an ongoing basis.

Internal control risks are minimised by the implementation of procedures for authorisation of all transactions and projects. Procedures are in place to ensure compliance with health and safety of staff and clients.

Likely future developments

Following completion of the merger with Canal Communities Local Drug and Alcohol Task Force and in the forthcoming years, the company plans to continue its current activities, subject to the ongoing existence of satisfactory funding arrangements.

Events after the end of the reporting period

There have been no significant events affecting the company since the year end.

Accounting records

Report on the audit of the financial statements

Opinion

We have audited the financial statements of Canal Communities Regional Addiction Service CLG (the 'company') for the financial year ended 31 December 2024 which comprise the profit and loss account, statement of income and retained earnings, balance sheet, statement of cash flows and notes to the financial statements, including a summary of significant accounting policies set out in note 3. The financial reporting framework that has been applied in their preparation is Irish law and FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland.

In our opinion, the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2024 and of its profit for the financial year then ended;
- have been properly prepared in accordance with FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland; and
- have been prepared in accordance with the requirements of the Companies Act 2014.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (Ireland) (ISAs (Ireland)) and applicable law. As part of an audit in accordance with ISAs (Ireland), we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

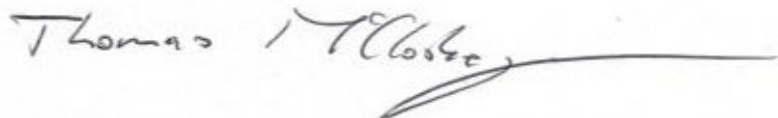

1. General information

The company is a private company limited by guarantee, registered in Ireland. The address of the registered office is Oblate Fathers, Tyrconnell Road, Dublin 8, D08 P6K8.

2. Statement of compliance

These financial statements have been prepared in compliance with FRS 102, 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'.

3. Accounting policies and measurement bases

Basis of preparation

The Financial Statements are prepared on the going concern basis, under the historical cost convention, and comply with the financial reporting standards of the Financial Reporting Council including FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the Companies Act 2014.

The financial statements are prepared in Euro, which is the functional currency of the entity.

Turnover

Grant income from Public Sector Bodies/Government Agencies and other sundry sources are credited when receivable or when the ultimate amount receivable can be assessed with reasonable certainty.

Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

Taxation

No charge to current or deferred taxation arises as the charity has been granted charitable status under Sections 207 and 208 of the Taxes Consolidation Act 1997, Charity No CHY 22690. Irrecoverable value added tax is expended as incurred.

Fund accounting

The following funds are operated by the charity:

Restricted funds

Restricted funds represent grants and sponsorships received which can only be used for particular purposes specified by the donors or sponsorship programme binding on the directors. Such purposes are within the overall aims of the charity.

Unrestricted funds

Unrestricted funds includes general funds and designated funds and it represents amounts which are expendable at the discretion of the directors in furtherance of the objectives of the charity and which have not been designated for other purposes. Such funds may be held in order to finance working capital or capital expenditure.

Designated funds

Designated funds are unrestricted funds earmarked by the directors for particular purposes. The designations of these funds have an administrative purpose only and do not legally restrict the directors' discretion in applying the funds.

4. Limited by guarantee

The company is limited by guarantee, not having a share capital and consequently the liability of members is limited, subject to an undertaking by each member to contribute to the net assets or liabilities of the company on winding up such amounts as may be required not exceeding one Euro (€1)
